  - f. In the event of a change of circumstance after date of this certification regarding any matter contained herein (items 4a – 4e), I will immediately and forthrightly notify the Cotillion Chairmen of the details of any such matter and
5. Attendance of rehearsals and activities that occur throughout the Cotillion season; and
6. No use of electronic media/devices allowed during Debutante Cotillion events as determined by Ivy Vine Charities, Incorporated.
